Date the final verdict will be announced:

Jury:

Will consist of those responsible for product design at Viefe®.

Who can enter?

Professionals worldwide from the fields of industrial design, designers and architects may take part, in addition to students over 18 years of age from any of those fields as well as those studying art.

How to enter?

All entrants must register themselves at viefe.com/design-competition-2021 and must then send, to the same web site, a PDF document containing their design proposal for kitchen furniture.

Requirements which the design must adhere to:

1. It must be an original design which hasn't received recognition or awards in any previous type of competition.
2. It must be a wall hook designed to fit any type of wall of homes or offices.
3. The entry document will be a single PDF with a draught design of the idea accompanied by a plan with the measurements and type of materials. If you wish, you may include a brief description of the concept behind the design.
4. Entrants must also send an image in JPG format (800 x 800 pixels). In sending this image the entrant provides authorization for Viefe® to use the image on its social networks, where the authors name will be cited at all times.
5. Only one entry will be accepted from each participant.

Choosing the winner:

From December 13 to 21th of 2021, those responsible for product design at Viefe® will choose the winning design and contact the design author. The jury will take into account the creativity of each entry received and the viability of the design.

Prize:

The author of the winning design will receive 1.000 euros + royalties derived from the possible commercialization of the design (if it is commercialized); the winner will also be able to form part of the team of collaborators at Viefe and their design can be included in the forthcoming Viefe® wall hooks catalogue.
